

MINUTES

Meeting of the Executive Committee
of the Board of Trustees of the
State Universities Retirement System
Friday, March 10, 2023, 12:00 p.m.
Via remote access only due to ongoing COVID-19 concerns

The meeting on March 10, 2023, was conducted via video conference pursuant to Public Act 101-0640, the Governor's Disaster proclamation dated March 3, 2023, and Section 7(e) of the Open Meetings Act. The Chair of the SURS Board of Trustees, John Atkinson, determined that a full, in-person meeting was not practical nor prudent due to ongoing COVID-19 disaster concerns.
