Meeting of the Ad Hoc Committee of the Board of Trustees of the State Universities Retirement System Monday, May 8, 2023, 3:00 p.m. State Universities Retirement System Via remote access only due to ongoing COVID-19 concerns

The meeting on May 8, 2023, was conducted via video conference pursuant to the Governor's COVID-19 Executive Order dated April 28, 2023, and subsection (e) of Section 7 of the Illinois Open Meetings Act. Chair John Atkinson of the SURS Board of Trustees determined that a full, in-person meeting was not practical nor prudent due to the ongoing COVID-19 disaster concerns.

UPDATE AND NEXT STEPS REGARDING THE CHIEF INVESTMENT OFFICER SEARCH

Mr. Michael Kennedy of Korn Ferry discussed the guidelines his team is working on to prepare the position description for the Chief Investment Officer (CIO) search. Mr. Kennedy and his team will be focusing on finding candidates that meet the following criteria: investment background in all asset classes, upper management skills, experience with boards, prior public pension experience, excellent communication skills, and a collaborative culture with focus on diversity. A first draft of the position description will be sent to Ms. Suzanne Mayer the week of May 15, 2023. Outreach will begin once the position description has been finalized and approved. Outreach is expected to continue during the following six weeks. The team at Korn Ferry will provide a weekly status report to Ms. Mayer, who will share those results with the Ad Hoc Committee. The expectation is to have the Ad Hoc Committee interview candidates and bring the top three candidates to the full board for final approval during the September board meeting.
