

CLOSED SESSION MINUTES

Meeting of the Investment Committee of the Board of Trustees of the State Universities Retirement System Thursday, December 8, 2022, 9:00 a.m. Via remote access only due to ongoing COVID-19 concerns

CONSIDERATION OF REAL ASSETS

Mr. Shane Willoughby and representatives from consultant, Callan, provided background information relating to Homestead Capital and Longpoint Realty, they discussed the proposed Real Assets commitments, and shared detailed information regarding the firms being considered.

TAIL RISK REPORT

Mr. Colin Bebee of Meketa presented a summary report of SURS Tail Risk Hedging program. During his report, Mr. Bebee covered costs, current portfolio positioning and major metrics of the program and explained how SURS investments work in this space.

MONDRIAN EMERGING MARKETS

Ms. Ghiané Jones and Mr. Alex Ramos stated that currently, Mondrian manages a global equity strategy on behalf of SURS. Within the separately managed account, access to emerging markets is achieved through a commingled Macquarie Emerging Markets Fund. Macquarie has announced

they are closing the fund but will keep it open until SURS decided on how to re-allocate the assets. Details regarding the breakdown of options for re-allocation was presented.

At this time, representatives from Meteta, Callan and Aksia left the closed session meeting and the board began its discussion of the General Consultant Search.

GENERAL CONSULTANT SEARCH CONCLUSION

Prior to the interviews, Ms. Ellen Hung noted the memorandum and summary materials in the board meeting materials that were provided by SURS staff.
